Divorce forms Please note that there isn't a form for a Separation Agreement. A Separation Agreement is a written contract that you write with your spouse that spells out how you're going to divide your property, child custody, child support, spousal support, visitation, and any other issues relevant to your divorce.

This means that you must prove to the court that your spouse has received the divorce papers. You must include the Complaint, the Summons, and a listing of attorney referral and legal services offices. You must serve the papers within 30 days of the date of filing, and provide proof of service to the court, in writing.

In Arizona, the legal name for a divorce is Dissolution of Marriage. The amount of time that takes to get a dissolution or divorce can vary from case to case. State laws require that you wait 60 days from the date of service before you can proceed with a divorce.

Where To Download Divorce Papers

Using DIY divorce papers is usually allowed only when the divorce is uncontested. An uncontested divorce is where you and your spouse have settled all major issues, such as child custody and spousal support. If you and your spouse have not agreed to every major issue, you have a contested divorce. Consult an attorney for a contested divorce.
